Admissions Policy for academic year 2019/20

The admissions policy has been designed to comply with the Schools Admissions Code 2012 and all relevant legislation, including that on infant class sizes and equal opportunities.

Admissions to the Reception Year

Subject to the criteria set out below, children will be admitted in the September following their fourth birthday. The academy has an agreed admission number (the published admission number or PAN) of 45.

Places will be allocated by the Local Governing Body on the basis of applications received through the Cheshire East admissions system. This allows parents/guardians to apply for entry to any Cheshire East primary school by means of the Cheshire East Primary School Common Application Form (CAF) available in the 'Applying for school Places' document published by Cheshire East Council (CEC) and on-line via the CEC website.

The school will offer places on a full time basis from the start of the Autumn Term.

"In-Year" Admissions

Admissions into year groups other than Reception will be on an in year transfer application basis and applications will be considered in the order in which they are received by the school. Applications can be made on the Local Authority online form, but they will be directed to the school for processing.

Oversubscription Criteria for all types of admissions

Once children with statements of special educational need or Education Health Care Plans have been admitted then places are allocated in accordance with the order of the following oversubscription criteria:

Criterion 1. 'Looked after children' and children who were previously 'looked after'.

A 'looked after child' is a child who is in the care of a local authority or being provided with accommodation by a local authority (as defined in section 22 of the Children Act 1989) at the time of making the application to school. Children previously 'looked after' are children who were looked after as defined above, but immediately after being 'looked after' became subject to an adoption, child arrangements order, or special guardianship order. An adoption order is an order under section 46 of the Adoption and Children act 2002. A 'child arrangements order' is an order settling the arrangements to be made as to the person with whom the child is to live under section 8 of the Children Act 1989. Section 14A of the Children Act 1989 defines a 'special guardianship order' as an order appointing one or more individuals to be a child's special guardian (or special guardians).

Criterion 2. Siblings

Pupils with brothers or sisters step-brothers or step-sisters, foster brother or sisters, half-brother or half-sisters, adopted brothers or adopted sisters living together as part of one household, already attending the preferred school (in years reception through to year 5) and expected to continue at the school in the following school year (i.e. at the time of admission)

Criterion 3. Children resident within the designated catchment area of the school

Children will be classed within this criterion if they and their parents/carers are resident

within the area served by the school.

Criterion 4. Pupils living nearest to the school

Measured using an Ordnance Survey address-point system which measures straight line distances in miles from the address point of the place of residence to the address point of the school.

An admissions panel including two governors not employed by the academy will apply the oversubscription criteria.

Fair Access Protocol

The academy participates in Cheshire East Local Authority Fair Access protocol.

Right of Appeal

In the event of an unsuccessful application, parents have the right to appeal to an independent appeals panel against non-admission. Appeal forms can be requested from the academy. Parents have at least 20 schools days to appeal from the date of the notification letter that they are not successful in their application for a school place.

Where an in year application and subsequent appeal are unsuccessful the Admissions Authority will not consider a repeat application within the same academic year unless there has been a relevant and significant change of circumstances relating to the application, or a place has become available in school.

Waiting lists

For entry into reception year, waiting lists are held until the end of the Autumn term. The school does not hold any other waiting lists.
